



Treasurer Vacancy

The Holst Birthplace Trust is a registered charity (number 1078599) and a company limited by guarantee (number 03874939). The Treasurer is both a trustee of the charity and a director of the limited company. Turnover in the financial year 2021-22 was almost £100,000.

The Trust manages the Holst Victorian House in Clarence Road, Cheltenham, a period home where the composer Gustav Holst was born. It is the only historic house open to the public in Cheltenham and the town's only independent museum. For more details see our website at <https://holstvictorianhouse.org.uk>.

The Trust owns the Grade II listed building at 4 Clarence Road which houses the museum, and is responsible for its upkeep; it also owns the majority of the museum's collections and is responsible for their conservation.

The museum employs two permanent part-time staff. Front of house duties and some other roles are delegated to volunteers. Strategic management is in the hands of a Board of Trustees which meets every six weeks.

Apart from a small grant from Cheltenham Borough Council, the Trust is funded entirely by admissions, donations and legacies.



This is a key role on the Board. The Treasurer is responsible for all the financial activities of the Trust, including the following:

1. Setting an annual budget for approval by Trustees and monitoring performance against it.
2. Providing advice to Trustees on safeguarding the Museum's financial viability.
3. Authorising expenditure in accordance with the Trust's Finance Policy; raising invoices for creditors and chasing payments; checking and paying invoices received.
4. Monitoring online banking sites and reconciling bank statements.
5. Keeping an accurate and up-to-date record of all income and expenditure and producing monthly management accounts for the Board.
6. Producing an annual financial report and accounts for the Trust's AGM; providing accounts and supporting documentation to the Independent Examiner; and submitting annual accounts to the Charities Commission and Companies House.
7. Submitting annual Gift Aid claims.
8. Banking cheques and cash as required.
9. Arranging appropriate insurance with the Trust's brokers.
10. Dealing with the financial transactions of the museum's small shop.

We are looking for a Treasurer who will take an active role in the strategic management of the Trust and play a full part as a Trustee in addition to the financial tasks associated with the role.

The Trust faces many of the challenges associated with running a small business and experience in such a role would be welcome, as well as experience in a similar capacity in another voluntary organisation or charity.

The role would start after our AGM on 18 July 2022 and the current Treasurer will spend whatever time and training is required to bring her replacement up to speed.
